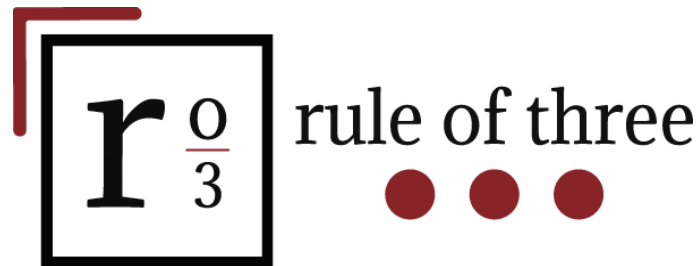

2023 PROGRAM WELCOME LETTER: LEAPS IN PATIENT SAFETY

When Neil Armstrong stood on the moon, he made a famous statement about one small step and one giant leap. The founders of Leapfrog remembered. They picked a quirky name for their own moonshot, a new national nonprofit to transform patient safety. They didn't call it "The Small Steps Forward Group."

Over our 23 years, The Leapfrog Group has been taking small steps and making some giant leaps. We see change. National indicators of patient safety are moving in the right direction, some dramatically. The pandemic stalled that movement, but those trends reversed recently, and we appear to be back on course. We are not there yet, but momentum gives us hope.

More signs of change:

- The President's Council of Advisors on Science and Technology (PCAST) issued a report on patient safety. Leapfrog's keynote speaker Joe Kiani led that effort, recommending strong and unified federal action on patient safety, supportive of Leapfrog policy goals.
- Health care providers increasingly focus on patient safety. Over 50% of hospitals and ASCs report that Leapfrog safety ratings are considered in senior leader compensation reviews, and we see prominent and significant national efforts by hospitals and health systems to tout the importance of patient safety. All of this was literally unheard of only a decade ago.
- We see the emergence of a new generation of employer executives who are advancing the value of health care delivered to employees and their families.
- Technology growth increasingly focuses on the needs of the patient, including technology for delivering better care and technology for monitoring—and driving to improve—health outcomes, nationally and globally. Whereas a decade ago about 2% of U.S. hospitals used electronic medical records or computerized prescriber order entry, today that's closer to 100%. Medicare claims data is public, and pricing and other data is available as never before on new digital platforms, including Leapfrog's. Our closing keynote speaker Dr. David W. Bates will give us insights on where that is headed.

For our next great leaps, we need you, our Leapfrog champions. Let's work toward our moonshot: save lives, prevent needless suffering, and bring about the promise of our country's extraordinary capacity to deliver excellent health care.

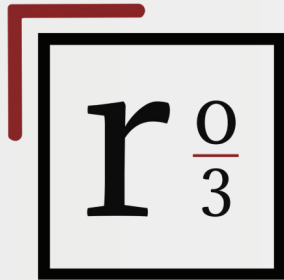

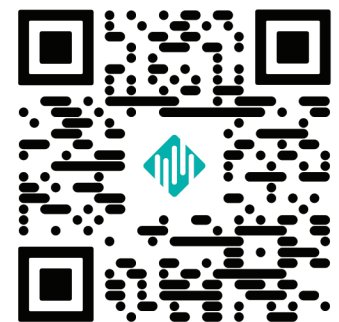

Joe Kiani, Founder, Patient Safety Movement Foundation; Founder and CEO, Masimo

Joe Kiani is co-chair of the patients safety work group within the President's Council of Advisors on Science and Technology (PCAST), the sole body of advisors from outside the federal government charged with making science, technology and innovation policy recommendations to the President and the White House. His desire to develop medical technology that improves patient care and decreases medical errors led him to co-invent what is known as modern pulse oximetry. Kiani serves as the Founder and CEO of global medical technology company Masimo that develops and produces a wide array of industry-leading monitoring technologies, including innovative measurements, sensors and patient monitors. He is also the founder of the Patient Safety Movement Foundation, a nonprofit that works towards eliminating deaths from preventable medical errors around the world.

David W. Bates, MD, MSc, Chief of General Internal Medicine, Mass General Brigham; Professor, Harvard Medical School and Harvard T.H. Chan School of Public Health

David Bates, MD, MSc, is an internationally renowned expert in patient safety and information technology and has published more than 1,200 peer-reviewed papers and is ranked among the 400 most-cited biomedical researchers of any type. He is a member of two of Leapfrog's Expert Panels: the Computerized Physician Order Entry Expert Panel and Hospital Safety Grade Expert Panel. He co-directs the Program in Clinical Effectiveness at the Harvard T.H. Chan School of Public Health and directs the Center for Patient Safety Research and Practice at Brigham and Women's Hospital. Bates is a member of the National Academy of Medicine and has been elected to the Institute of Medicine, American Society for Clinical Investigation, Association of American Physicians and American College of Medical Informatics.

Rebecca Bartles, Executive Director, Association for Professionals in Infection Control and Prevention (APIC) Center for Infection Prevention and Control Research, Practice and Innovation (CIPCRPI)

Rebecca Bartles is a fellow at the Association of Professionals in Infection Control (APIC) who has practiced infection prevention and infectious disease epidemiology for the last 18 years in a variety of health care settings. She has numerous publications focused on infection prevention staffing and endoscope safety. Bartles also teaches courses at the University of Providence for a master's in infection prevention degree program that she founded in 2016. She has been certified in infection control since 2008.



Lee Fleisher, MD, Emeritus Professor of Anesthesiology and Critical Care and Professor of Medicine, University of Pennsylvania Perelman School of Medicine

Lee A. Fleisher, MD, was the chief medical officer and director of the Center for Clinical Standards and Quality for the Centers for Medicare and Medicaid Services (CMS). In this capacity, he was responsible for executing all national clinical, quality and safety standards for health care facilities and providers, as well as establishing coverage determinations for items and services that improve health outcomes for Medicare beneficiaries. A founding member of the Leapfrog Outpatient Surgery Expert Panel, he serves as a senior advisor of the Bipartisan Policy Center, senior Fellow of the Leonard Davis Institute of Health Economics and Visiting Fellow of the Duke-Margolis Center.



Krista Hughes, BCPA, Founder and CEO, Hughes Advocacy

Krista Hughes, BCPA, is a board-certified patient advocate and has more than 25 years of experience working in the medical industry, where she equips, empowers, educates and teaches patients how to get the best care they need and deserve. She was appointed by U.S. Secretary of Health and Human Services (HHS) Xavier Becerra to serve a three-year term on the National Advisory Council (NAC) for the Agency for Healthcare Research and Quality (AHRQ).



Susan E. Sheridan, MIM, MBA, DHL, Founding Member of Patients for Patient Safety US (PFPS US); Director of Patient Engagement Emeritus, Society to Improve Diagnosis in Medicine (SIDM)

Susan E. Sheridan, MIM, MBA, DHL, is on the Leapfrog Board of Directors and the co-chair of Leapfrog's Patient and Family Expert Panel. She became involved in patient safety after her family experienced two serious medical system failures. For nearly 30 years, Sheridan has been advocating for increased transparency in health care and improved patient safety, including most recently serving on a workgroup advising President Biden on patient safety through the President's Council of Advisors on Science and Technology (PCAST). Her expertise includes intersectional work with the World Health Organization (WHO), the Gordon and Betty Moore Foundation and other initiatives before founding Patients for Patient Safety.



Stephanie Taylor, MD, MArch, CEO, Building 4 Health, Inc.; InCite Health Fellow, Harvard Medical School

Stephanie Taylor, MD, MArch, received her MD from Harvard Medical School in Boston, Massachusetts. For the next several decades she practiced clinical medicine in pediatric oncology and did research on cellular growth control mechanisms. She then returned to school and obtained her master's degree in architecture, determined to gain a better understanding of the impact of the built environment on patient healing. With new insights, Taylor delved into research on the relationship between indoor environments and clinical outcomes of hospitalized patients. In 2019 she founded Building4Health, Inc. to scale the powerful yet underutilized approach of IAQ management for disease prevention.



Robert Otto Valdez, PhD, MHA, Director, Agency for Healthcare Research and Quality (AHRQ)

Robert Otto Valdez, PhD, MHA, was appointed director of AHRQ in February 2022. He was previously the Robert Wood Johnson Foundation (RWJF) Professor Emeritus of Family and Community Medicine and Economics at the University of New Mexico (UNM). From 1993 through 1997, Valdez served at the U.S. Department of Health and Human Services (HHS) simultaneously as deputy assistant secretary for health (Public Health Service) and director of Interagency Health Policy (Centers for Medicare and Medicaid Services [CMS]). Before joining HHS in 1993, he served as a special senior advisor to the Clinton White House on health care reform.



Karen van Caulil, PhD, President and CEO, Florida Alliance for Healthcare Value

Karen van Caulil, PhD, is a Leapfrog Board member and Regional Leader. She is the longtime leader of the Florida Alliance for Healthcare Value, a coalition made up of large Florida employers working to improve the quality of health care delivered throughout the state. The Alliance is formally recognized as a Leapfrog Regional Leader for the state of Florida. A respected leader in employer health benefits strategy and health data analytics, van Caulil represents the Florida Alliance's mission and work locally, regionally and nationally, actively serving on numerous boards, advisory committees and workgroups for organizations such as the National Alliance of Healthcare Purchaser Coalitions, Catalyst for Payment Reform, Florida's Agency for Health Care Administration, Get the Medications Right Institute, the Society to Improve Diagnosis in Medicine and many others.



Shaunté Walton, MS, CIC, FAPIC, System Director, Clinical Epidemiology and Infection Prevention, UCLA Health

Shaunté Walton, MS, CIC, FAPIC, is responsible for oversight of the infection prevention program of all inpatient hospitals and 260+ ambulatory clinics at UCLA Health. Shaunté is a trained molecular microbiologist and has more than 15 years of infection prevention experience, including pediatric and women's services, adult and pediatric transplant services, oncology, neurology, critical care, surgical services, heart and vascular services, rehab services and orthopedic services. Most recently, overall infection reduction efforts at UCLA Health were highlighted the *Newsweek* World's Best Hospitals and U.S. Best Hospitals for Infection Prevention Award in 2021.



Sally Welborn, Welborn Advisory Associates

Sally Welborn is a member of the Leapfrog Board of Directors. She currently advises employers, health care organizations, entrepreneurs and others in the health care and employee benefits arenas. She works extensively as the executive advisor to the Employer Health Innovation Roundtable (EHIR). 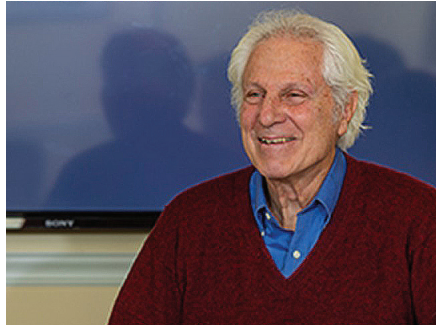


Gaye Fortner

Gaye Fortner led a Nashville-based business coalition that was among the first six to sign on as a Leapfrog Regional Leader. As CEO of HealthCare 21 Business Coalition for over 23 years, she helped lead the Coalition’s merger last year with the Memphis Business Group on Health to form HealthCareTN, which she co-led with Cristie Travis. She was a forceful and effective advocate for transparency, quality and safety and helped guide Leapfrog to many victories.

Gaye was a pillar in her community, where she was born and raised. A nurse by training, she successfully worked with employers to deploy innovative, value-based approaches that improved the health of their employees and the people of Tennessee. Many were cited at the national level. She oversaw a number of impactful studies dedicated to the management of chronic diseases, high-risk conditions and value-based benefit designs.

At Leapfrog, we counted her as a wise and caring partner—literally from day one, she was our champion. Most of all, she was a loyal and warm friend to all of us who had the privilege and the joy to work with her.



Robert Merrill Krughoff

Robert Merrill Krughoff was an early pioneer of the audacious idea of comparing the quality and safety of health care providers. He was among the first to utilize The Leapfrog Group’s hospital ratings back in the early 2000s. He gave us the benefit of his vast experience to help us be as meticulous as he was in gathering and reporting reliable health care ratings.

After a stint at the U.S. Department of Health, Education, and Welfare (now the Department of Health and Human Services), he founded and published the first issue of Consumer Checkbook, a guide to compare local products and services on price and quality, which grew to cover comparisons of health care providers. He was issuing ratings in the 1970s, long before anyone did that in health care. He spent countless hours fighting for the public release of health care performance data.

He served as a Leapfrog Regional Leader and informal expert advisor. He was exceptionally well regarded for his expertise and his kindness. Leapfrog is better today because we traveled pathways he paved for us, and we benefit from his legacy every time we publish our ratings.



Andrew Webber

Andy Webber was Leapfrog’s friend since our founding in 2000, and he served on our Board from 2004 to 2010. During that time, Andy was the President and COO of the National Business Coalition on Health (now National Alliance of Healthcare Purchaser Coalitions), where he galvanized business groups across the country to advance transparency, measure quality and safety and drive value-based payment reform. Most of those business groups are now Leapfrog Regional Leaders.

Many of the public reporting programs our country relies on today arose from Andy’s national influence, including measurement and payment programs at Centers for Medicare & Medicaid Services (CMS). In 2013 Andy moved to Maine, where he was President & CEO of the Maine Health Management Coalition (now the Healthcare Purchaser Alliance of Maine), a longstanding Leapfrog regional leader. Later he worked for the boutique firm Discern Consulting, where his expertise in value-based care was widely deployed.

Andy’s friendship was prized by our entire board and staff.

Award Winner



Charles Holland
President and Chief Executive
Officer, St. Bernard Hospital
and Health Care Center

The winner of the 2023 Steven Schroeder Award for Outstanding Healthcare CEO, presented by Costs of Care and The Leapfrog Group, is Charles Holland, president and CEO of St. Bernard Hospital. Mr. Holland was selected for this award for his leadership as the president and CEO of an independent Catholic safety-net community hospital in the South Side of Chicago that's embarked on a remarkable quality and safety improvement journey over the last few years. St. Bernard Hospital has committed to ethical financial practices and invested in better outcomes for patients.

Since joining the leadership team of St. Bernard Hospital in 1998, Mr. Holland has been instrumental in building the stature of the hospital as a force in stabilizing the neighborhood and addressing the needs of its underserved residents. He led the hospital's 77 home affordable housing project, Bernard Place, which won the prestigious Richard H. Driehaus Award for Outstanding Non-profit Neighborhood Real Estate Project in 2004. He guided the development of pivotal programs such as the Pediatric Mobile Health Unit and the St. Bernard Hospital Dental Center.

As the leader of St. Bernard's strategic planning efforts, Mr. Holland led the Senior Management Team in the development of the hospital's state-of-the-art Ambulatory Care Center, which opened in 2016. An unwavering advocate for health equity, Mr. Holland chairs the board of the Center for Better Aging at St. Bernard Hospital, a Healthcare Transformation Collaborative focused on the needs of older adults. He also sits on the board of the South Side Healthy Community Organization, a comprehensive transformation project that aims to improve patients' access to care and enhance coordination among local providers.

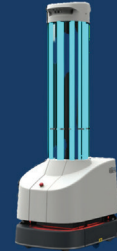

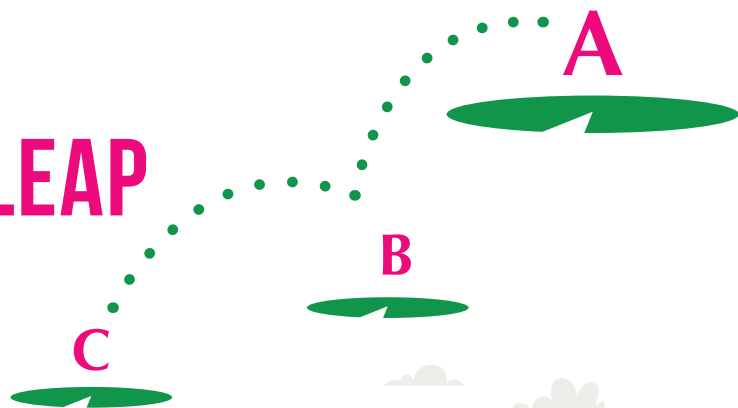

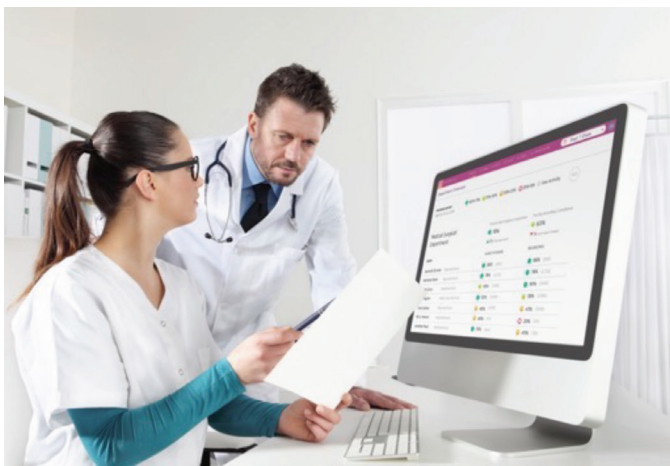
